

## Instanties voor het afgeven van in- en uitvoercertificaten in de EU

### Authorities competent for receiving applications and issuing licences and extracts

In accordance with Article 20(3) of Commission Implementing Regulation (EU) 2016/1239 laying down rules for the application of Regulation (EU) No 1308/2013 of the European Parliament and of the Council with regard to the system of import and export licences<sup>1</sup>:

*"Member States shall notify information on the Uniform Resource Locator (URL) of the web address of the authorities competent for receiving applications and issuing licences and extracts as referred to in Article 2(2) to the Commission, and shall keep that information updated and send it again when necessary. The Commission shall publish the URLs concerned on its public website."*
