



Factsheet GlobalStars – Brazil

Commissioned by the Ministry of Economic Affairs and Climate

The funding bodies FINEP, FAPESP and EMBRAPA of Brazil and RVO.nl of The Netherlands, in cooperation with FFG of Austria, VLAIO of Flanders region, BPIFrance of France, DLR-PT of Germany, CDTI of Spain and Innosuisse of Switzerland have announced a GlobalStars call for collaborative industry-led R&D projects aimed at creating innovative products, processes and services. In this call, Dutch companies are invited to submit joint R&D project proposals with a project partner from Brazil. Deadline for submission of the proposals is **October 31, 2018 at 17:00 CET**.

The call is managed using the EUREKA platform for trans-borders innovation. The project consortium should include at least one Dutch company and at least one Brazilian organisation. Dutch research organisations can participate as additional partner. Organisations from Austria, Flanders, France, Germany, Spain or Switzerland may also participate. They can be funded by their national funding bodies and according to their own national regulations. Projects without a Brazilian partner are not eligible for funding.

Scope

This call invites projects proposals in **all thematic areas**. We encourage companies active in the field of Bio-economy, Health and HTSM sector to put forward their proposals. Military applications are excluded.

Timelines

- Opening of the call: July 5, 2018
- International submission deadline: October 31, 2018 at 17:00 CET
- National submission deadline: early 2019
(actual dates to be published)
- Consensus meeting: April 1, 2019
- Funding decision and project start: before August 31, 2019

Funding in The Netherlands

There is no minimum or maximum in eligible project costs. The maximum funding per project for all Dutch project partners involved is € 350,000. The amount of funding depends on the

type of activity and the type of organisation. See table for the subsidy percentages used in The Netherlands.

Large enterprise	35 %	25 %
Research organisation	50 %	25 %

In the Netherlands a total of approximately € 950,000 is available for grants for this GlobalStars call (actual budget to be published).

Apply

If your project matches the criteria, please submit your international application before October 31, 2018 (17.00 hours CET). The application consists of an EUREKA Project Form sent to EUREKA office in Brussels. Eligible consortia will be invited to submit a national application to the relevant Brazilian funding body and RVO. Interested organisations are strongly advised to contact the national funding bodies to discuss their project ideas prior to the submission of the application.
