## Chapter 1 Preface

Thank you for using the registration management system for overseas manufacturers of imported food. The user manual is provided to enable you to use this system proficiently as soon as possible.

You can find in this manual information on installation procedures, system configuration, and basic operation procedures, software and hardware instructions, and safety precautions. Please read this manual carefully when installing and using the system for the first time as it will help you to get the most out of the system.

This manual is intended for users with elementary computer knowledge. Here, we assume you are familiar with WINDOWS7/10 system and can operate with computer mouse, and have experience in using browsers such as Google Chrome, 360 etc.

## Chapter 2 Instructions for Use

### 2.1 Portal Website

The system is browser-based and can be found at <https://cifer.singlewindow.cn> .

### 2.2 System Environment

#### 2.2.1 Operating System

Windows 7 or 10 (either 32-bit or 64-bit operating system). Windows XP system is not recommended.

#### 2.2.2 Browser

Chrome 50 and above

### 2.3 Input Requirements

#### 2.3.1 Input Requirements

In the interface, required fields are marked with an asterisk \* while optional fields are not. The fields with grey background are not available for input. If a red alert pops up next to a field when inputting, it indicates that the information currently entered does not meet the requirements and should be modified according to the alert. The blue buttons in the interface are function keys.

## 2.3.2 Keyboard Operations

Some functions in the interface can be operated quickly by the keyboard.



Pressing the **Tab** key makes the text cursor automatically advance to the next field.

Pressing the **Up or Down Arrow** key allows you to select from the parameters in the drop-down menu on the screen.


Pressing the **Backspace** key can delete the information currently entered in the field.

## 2.4 General Functions

### 2.4.1 Move Page Tab

If there are many opened page tabs, you can click on the  or  icon to move to the left or right one for selection.

### 2.4.2 Collapse/Expand Menu

Click the  icon in the upper left corner of the right display area to collapse or expand the menu bar on the left side. The collapsed left menu bar shows only the icons (as shown below).

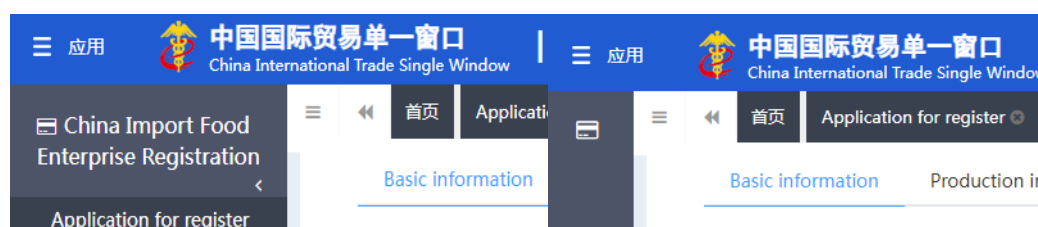



Figure: Before and after comparison - collapsed left menu bar

### 2.4.3 Close Tabs

Click the icon  in the upper right corner of the right display area to bring up a drop-down menu (as shown below). Selecting “Close all tabs” will close all web tabs opened in the current display area. If you select “Close other tabs”, you will close all open tabs except for the currently displayed tab.

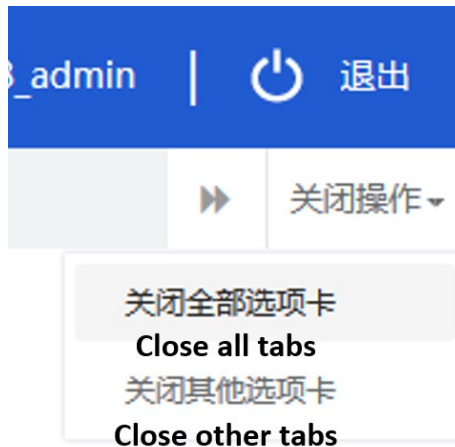



Figure: Close tab

### 2.5 Enter or Exit the System

Visit <https://cifer.singlewindow.cn>, enter the username and password to log in to the system and then enter the main interface of the system. Click on the  icon in the upper right corner to select the display language of the system.

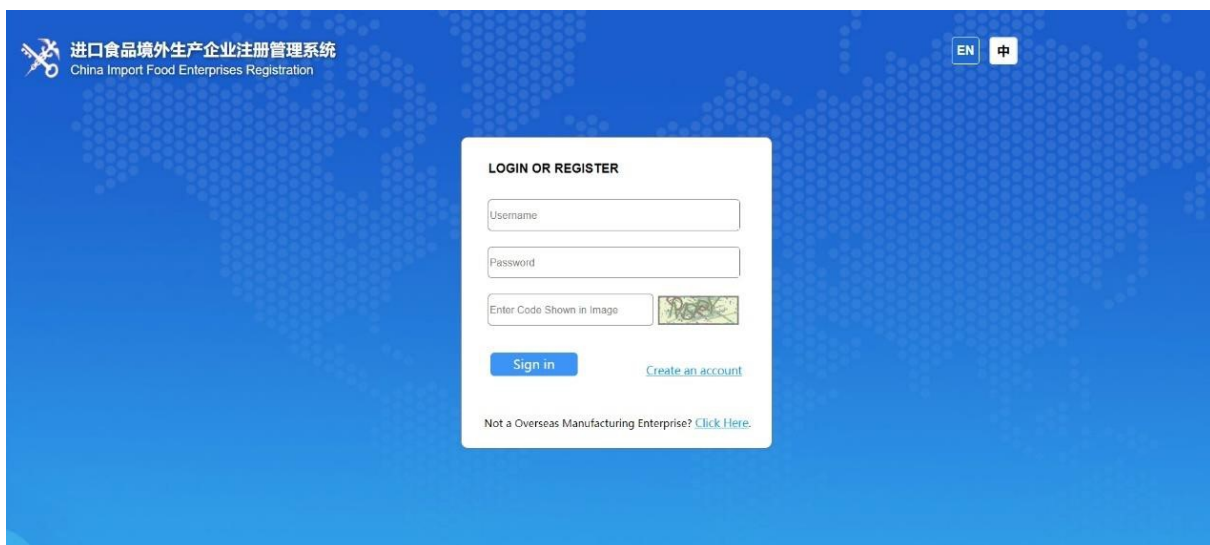


Figure: System portal

This system is available for overseas enterprise users and overseas competent authorities users. You can safely exit the system by clicking “Exit” in the upper right corner of the interface after entering the system.

## **Chapter 3 Introduction to the System**

### **3.1 Users**

**Competent authority of the country/region where the enterprise is located (hereinafter referred to as "competent authority"):** the official department responsible for safety and health supervision of food manufactures in the country/region where the overseas manufacturers of imported food are located. Through the system, competent authority shall review and inspect the applications submitted by the local manufactures through the system and recommend them to the General Administration of Customs of the People's Republic of China (hereinafter referred to as the "GACC"). The competent authority shall administer the registered recommended enterprises and cooperate with GACC to re-examine and supervise the rectification of registered enterprises.

**Overseas manufacturer of imported food (hereinafter referred to as "enterprise"):** overseas manufacturers, processors and storage facilities that exported food to China. Through the system, enterprises submit registration application and rectification materials and receive notice from GACC, etc.

### **3.2 Functions**

China Import Food Enterprise Registration Management System aims administer the registration of overseas manufactures of imported food, including applications, alteration, renewal, and cancellation for overseas manufactures registration, as well as querying about the applications. It also enables the competent authority to conduct review and inspection the registration applications submitted by enterprises, as well as the administration on registered manufactures.

The registration methods for overseas manufacturer of imported food include recommendation for registration by the competent authorities of the countries or regions where they are located and application for registration by enterprises.

Overseas manufactures of the following 18 categories of imported food shall be recommended by the located competent authorities to the GACC: meat and meat products, casings, aquatic products, dairy products, bird's nest and bird's nest products, bee products, egg and egg products, edible oil and fats, oilseeds, stuffed pastry products, edible grains, milled grain industry products and malt, fresh and dehydrated vegetables and dried beans, condiments, nuts and seeds, dried fruits, unroasted coffee beans and cocoa beans, foods for special dietary purposes and functional foods.

Overseas manufactures of food other than those categories listed above shall apply for registration directly to GACC on their own.

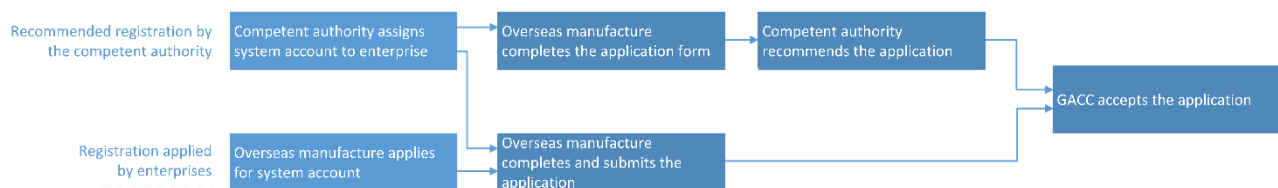


Figure: Registration procedures

## Chapter 4 User (Account) Management

Depending on whether the enterprise needs to be “recommended by the competent authority for registration of the country/region where it is located”, the account for overseas enterprise users to access the system can be obtained either through the assignment of the competent authority or the self-application of overseas enterprise.

The system account assigned by the competent authority can be used to register an overseas manufacturer of any categories of food after logging in to the system.

The system account applied by the overseas enterprise can only be used to register an overseas



manufacturer of imported food products that do not fall into one of the “18 categories”.

If an enterprise has already created a system account, which allows it to register as an overseas manufacturer of imported food products other than the “18 categories”, and is willing to be allowed to register as an overseas manufacturer of imported foods within the “18 categories”, please contact the competent authority in your country (region) to verify the enterprise user account you already have. There is no need to withdraw your account and then have it recreated by the competent authority.

***Kind reminder:***

***1. An overseas enterprise can only apply for one account.***

***2. If the products of an overseas manufacture involve both "recommended registration" and "self-applied registration", it is recommended to contact the competent authority to get a system account instead of applying for a system account by its own.***

#### **4.1 System Account Assigned by Overseas Competent Authority**

Please contact the competent authority to get an assigned system account.

#### **4.2 System Account Applied by Enterprise**

Visit <https://cifer.singlewindow.cn> and click "Create an account" to enter the account entry interface and fill in the account information.

***Once an account is successfully created, the information of username, located country/region, and country/region registration number shall not be modified. Please check them carefully during registration.***

### 4.3 Overseas Enterprise User (Account) Maintenance

After logging in to the system, click on the enterprise name in the upper right corner to access the user (account) maintenance function.

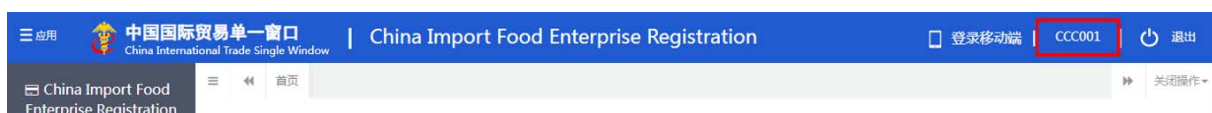


Figure: User (account) maintenance access

## Chapter 5 Enterprise Registration

### 5.1 Registration Application

After logging in to the system with overseas enterprise account, click on "Registration Application" in the menu on the left and select the product category involved in enterprise registration. The product category can be queried according to HS code or product name through "Product Type Query" functions (please refer to section 5.3 for this manual).

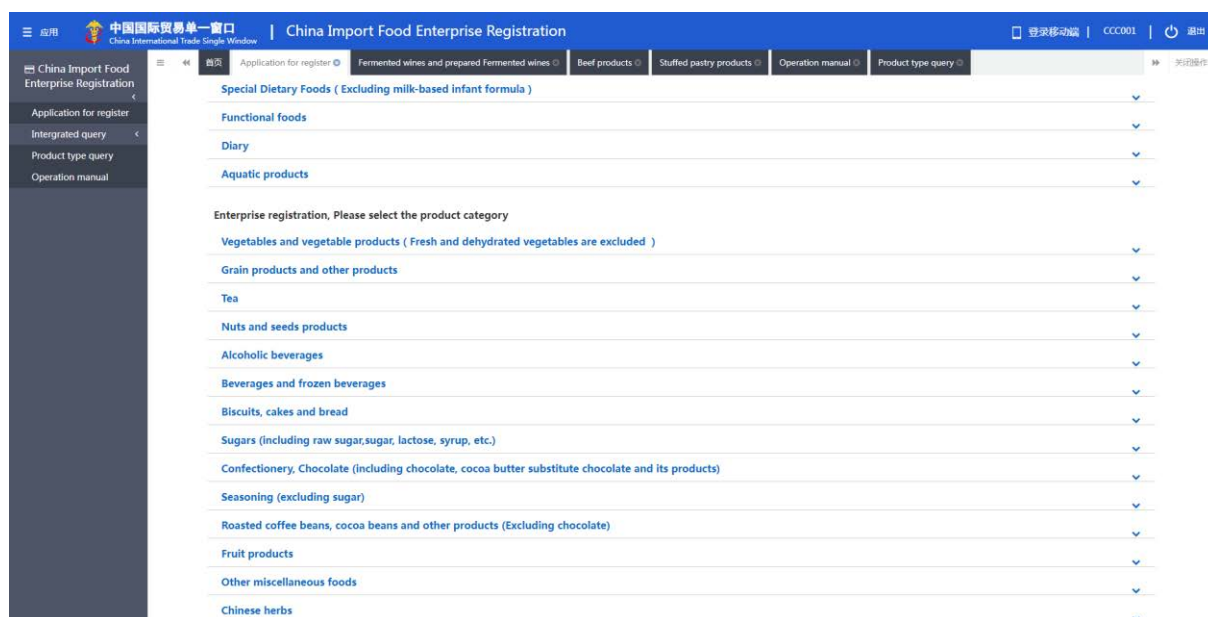


Figure: Product category selection for registration application

Overseas manufactures of the following product groups must be recommended by the competent authority of the country/region where they are located for registration with GACC: meat and meat products, casings, aquatic products, dairy products, bird's nests and bird's nest products, bee products, eggs and egg products, edible oils and fats, oilseeds, stuffed pastry products, edible grains, milled grain industry products and malt, fresh and dehydrated vegetables, dried beans, condiments, nuts and seeds, dried fruits, unroasted coffee and cocoa beans, foods for special dietary purposes, and functional foods.

Overseas manufactures of food other than those product groups listed above shall apply register directly with GACC.

#### 5.1.1.1 Introduction to the Registration Process (Taking Stuffed Pastry Products as an Example)

Registration process:

##### 1. General approval process

Enter information → Preview → Submit to the competent authority → Recommended by the competent authority → Approved by GACC (the enterprise obtains the Chinese registration number).



2. The process of returned by the competent authority for supplementation and correction.

Enter information → Preview → Submit to the competent authority → Requested by the competent authority to supplement and rectify → (The enterprise) modifies the application and re-submit to the competent authority → Recommended by the competent authority → Approved by GACC (the enterprise obtains the Chinese registration number).

3. The process of return (rejection) by the competent authority or GACC.

Enter information → Preview → Submit to the competent authority → Rejected by competent authority (the reasons for rejection can be found in the "Integrated query – application form query").

#### **Kind reminder:**

***Applications that are not recommended by the competent authority may not be resubmitted with amendments to the original application form. However, it is permitted to submit a new application.***

Main functions:

1. Save: the basic information of the enterprise, production-related information, declaration information and attachment information which have been entered can be saved temporarily.

Temporarily saved data can be deleted or submitted to the competent authority.

- Registration number approved by located competent authority: it is automatically filled in by the system according to the "Registration number approved by located competent authority" entered by the user when creating the account.
- Name of the registration approval competent authority: the overseas official authority that approved the establishment of the enterprise, i.e. the authority of the country/region that granted the "located country (region) registration number". Optional field.
- Name of competent authority of the country (region): the name of the authority that assigned a user account to the enterprise. Click on the blank or the triangle icon on the right to select.
- Registration number (in China) / Registration date (in China) / Registration expiration date (in China): it cannot be filled in when entering, for it will be given by the GACC after the approval of the registration application. The number can be found through the function of the "application form query".
- Enterprise name: it is a required field automatically filled in by the system based on the information of the user account. This field can be edited, but modification is not recommended.

Overseas manufactures of food products other than the 18 food categories recommended for registration by the located competent authority apply for registration with GACC on their own.

After logging in to the system with overseas enterprise account, click on "Registration Application" in the menu on the left, and select the product(s) for which the enterprise can apply for registration with GACC. The following is an example of "Alcoholic beverages – Fermented wines and prepared fermented wines".

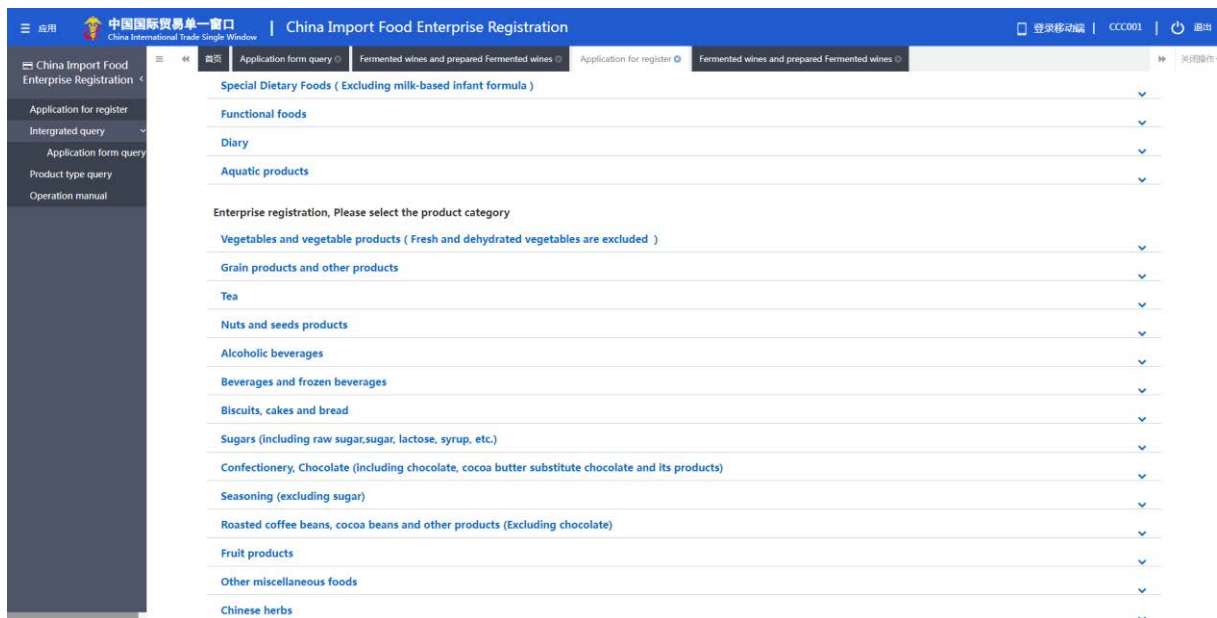


Figure: Product category selection for registration application

#### 5.1.2.1 Introduction to the Registration Process (Taking Alcoholic beverages – Fermented wines and prepared fermented wines as an Example)

Registration process:

##### 1. General approval process

Enter information → Preview → Submit to GACC → Approved by GACC (the enterprise obtains the Chinese registration number).

2. The process of returned by GACC for supplementation and correction Enter information → Preview → Submit → Requested by GACC to supplement and rectify → (The enterprise) modifies

the application and re-submit the application → Approved by GACC (the enterprise obtains the Chinese registration number).

### 3. The process of return (rejection) by GACC

Enter information → Preview → Submit → Rejected by GACC (the reasons for rejection can be found in “Customs feedback” through the "Integrated query").

#### **Kind reminder:**

**Applications that are rejected by GACC may not be resubmitted with amendments to the original application form. However, it is permitted to submit a new application.**

Main functions:

Submit: the application data is submitted to GACC for review.

Other functions such as deletion and query are basically the same as those of the application page for the competent authority to recommend products to the GACC for registration.

- Registration number approved by located competent authority: it is automatically filled in by the system according to the "Registration number approved by located competent authority" entered by the user when creating the account.
- Name of the registration approval competent authority: name of the overseas official authority that granting the qualification of the enterprise. It is also the organisation that issues the enterprise the "Registration number approved by located competent authority". Optional field.
- Registration number (in China) / Registration date (in China) / Registration expiration date (in China): enterprise's registration number in China granted after GACC's approval. It cannot be filled in when entering, for it will be given by the GACC after the approval of the registration application. The number can be found through the function of the "application form query".
- Enterprise name: it is a required field automatically filled in by the system based on the information of the user account. This field can be edited, but modification is not recommended.
- Products to be registered/added to China: required. After clicking "Add", the interface of entry will pop up and multiple products' information can be entered.

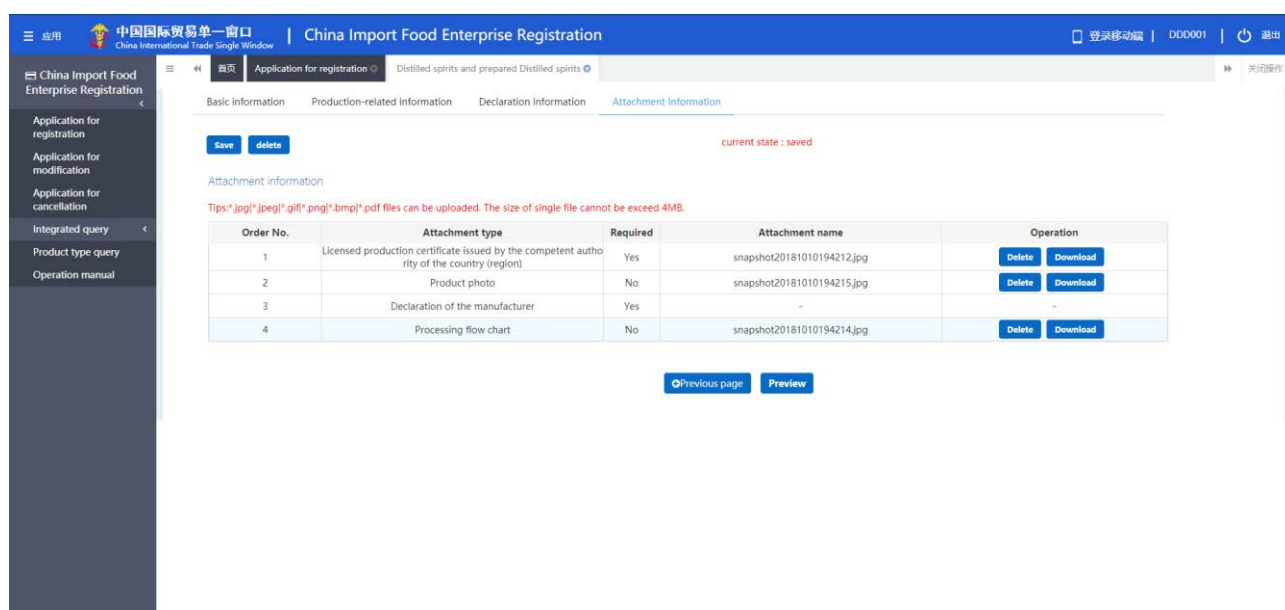


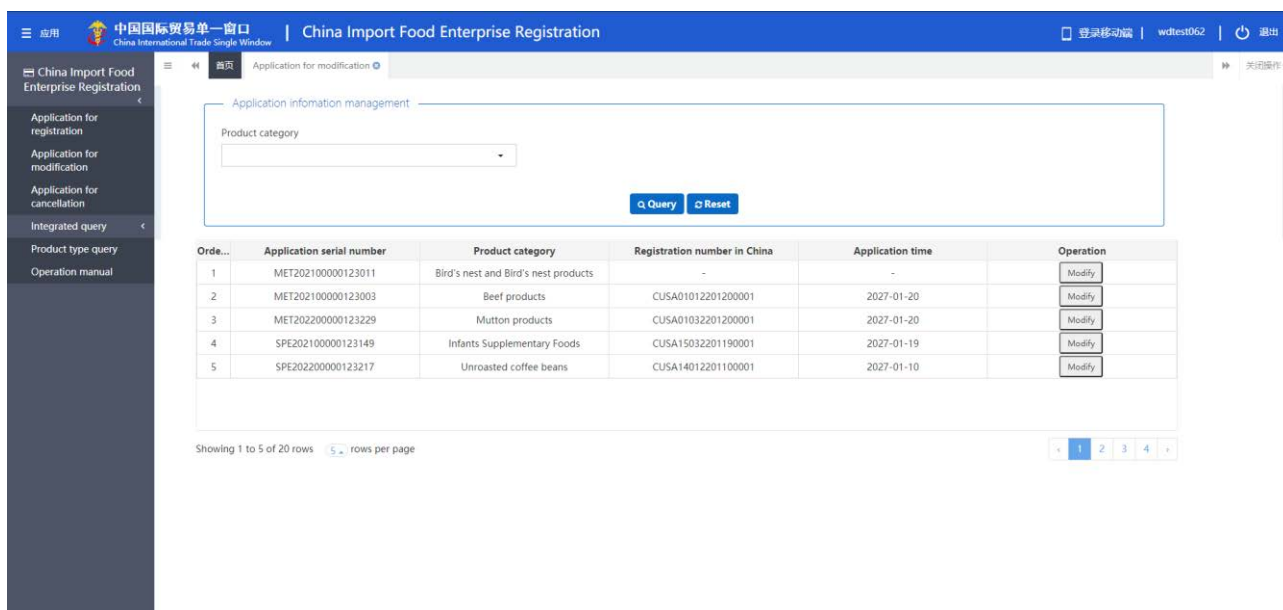

### 5.2.1.1 Introduction to the modification process

Modification process (take “Sheep intestine casings” as an example):

#### 1. General approval process

Enter the information → Preview → Submit to the competent authority → Competent authorities recommendation → GACC approval (registration information will be updated to the latest contents submitted for modification)

#### 2. Submission returned by the competent authority for supplementation or correction

Enter the information → Preview → Submit to the competent authority → Competent authority's request for supplementation and correction → Modify the application and re-submit it to the competent authority → Competent authorities' recommendation → GACC approval (registration information updated to the latest content submitted for modification)

#### 3. Submission returned by the competent authority (Recommendation denied) or GACC approval not granted

Enter the information → Preview → Submit to the competent authority → Submission returned by the competent authority (Recommendation denied)

Enter the information → Preview → Submit to the competent authority → Competent authorities submit the information to GACC → GACC approval not granted (the reasons for the rejection can be found in through "Integrated query" - "Application form query"; re-select the approved registration on the “Application for modification” page to apply for new modification)

#### **Kind Reminder:**

***For applications rejected by the competent authority (recommendation denied), it is not possible to make changes to the original application and submit it again. However, it is allowed to apply for new modification.***

Main functions:

1. Save: the basic information about the enterprise, production-related information, declaration information and attachment information which have been entered can be saved temporarily.

Temporarily saved data can be deleted or submitted to the competent authority. Data returned by the competent authority for supplementation or correction can be edited.
