Despite recent improvements, the health of Romania's population is still below the EU average. The avoidable mortality rate is two and a half times higher than the EU one. Healthcare spending is relatively low and staff shortages remain a problem.

Territorial imbalances in the provision of healthcare services are large and widening.

Primary health care, specialized outpatient health care, hospitals, the public health sector and the social care sector operate in a fragmented manner, obstructing population's access to integrated medical services.

The capacity in primary care, in specialized outpatient clinics is unevenly distributed and underused, so that most medical services continue to be provided in hospitals. The system is due to enter an accelerated reform that will see the market for medical equipment, digital solutions and medical services grow significantly.

Almost 7 billion Euro are allocated from European funds for the modernisation of clinical facilities and the extension of primary and outpatient care in the coming years.

The two main funding sources are the National Recovery and Resilience Plan (NRRP) and the Healthcare Operational Programme. The list hereunder describes the main NRRP investments in the coming period.

1. GP offices or associations of primary care offices

estimated budget: 180 million Euro completion by: May 2024

2. Mobile medical units (Caravans)

estimated budget: 4 million Euro completion by: May 2024

3. Ambulatory healthcare facilities

estimated budget: 120 million Euro completion by: November 2024

4. Integrated community centers

estimated budget: 50 million Euro completion by: August 2024

5. Family planning offices

estimated budget: 10 million Euro completion by: July 2025

6. New public healthcare facilities

estimated budget: 2.1 billion Euro completion by: June 2026

7. Equipment and materials for reduction of nosocomial infections risk

estimated budget: 210 million Euro completion by: May 2024

8. Neonatal intensive care units

estimated budget: 80 million Euro completion by: November 2024

Investment/Activity
